### **Informed Consent: Permanent Pacemaker Implant**

This information is given to you so that you can make an informed decision about having a **Permanent Pacemaker Implant with moderate sedation or anesthesia**.

## Reason and Purpose of the Procedure:

A small battery powered generator (pacemaker) is implanted in patients who have problems related to slow heartbeat, irregular heartbeat, or other abnormal heart rhythms. Those problems include shortness of breath, tiredness and dizziness.

A small cut is made in the chest after it is numbed. Your doctor inserts pacer lead(s) through a vein in your chest that is connected to your heart. These leads are connected to a pacemaker. It is inserted into a pocket made under the skin.

### **Benefits of this Procedure:**

You might receive the following benefits. Your doctor cannot promise you will receive any of these benefits. Only you can decide if the benefits are worth the risk.

- Your heart may beat normally.
- Symptoms may get better. These may include:
  - Tiredness.
  - Shortness of breath.
  - Dizziness.
  - The feeling of your heart beating hard in your chest.

### **Risks of Procedure:**

No procedure is completely risk free. Some risks are well known. There may be risks not included in the list that your doctor cannot expect.

### Risks of this procedure:

- Bruising and/or swelling at the puncture. This may need surgery.
- Blood loss. Fluids or possibly a blood transfusion may be needed
- Abnormal heart rhythms. Fluids and medicines may be needed.
- Stroke. Rehabilitation may be needed.
- Infection. Antibiotics or other treatment may be needed
- The procedure may not cure or relieve your condition
- Additional tests or treatment may be needed.
- Death may occur.
- Heart Attack.
- Your doctor may not be able to place the device in the desired location.
- Pneumothorax, also known as a lung puncture. Emergency surgery may be needed.
- Reaction to the anesthetic may occur. The most common reactions are nausea and vomiting. In rare cases, death may occur. The anesthesiologist will discuss this with you.

#### **Information on Moderate Sedation:**

You will be given medicine in an IV to relax you. This medicine will also make you more comfortable. This is called "moderate sedation". You will feel sleepy. You may even sleep through parts of your procedure. We will monitor your heart rate and your blood pressure. We will also monitor your oxygen level.

If your heart rate, blood pressure or oxygen levels fall outside the normal range, we may give medications to reverse the sedation. We may be unable to reverse the sedation. We may need to support your breathing. Even if you have a NO CODE status:

- You may need intubation to support your breathing.
- You may need medications to support your blood pressure.

We will re-evaluate your medical treatment plan and your NO CODE status when sedation has cleared your body.
